## Featured Project

### *Jacob's Well Natural Area, Project #603*

Once considered a sacred area by the Native Americans, Jacob's Well is a natural spring and is believed to be the longest underwater cave in Texas. It is the primary source of water for Cypress Creek which flows through Woodcreek and Wimberley and then into the Blanco River.

Jeff Vasgaard is the HCMN contact for the project. Jeff was in the class of 2009 and has an Agricultural Engineering and Materials Science background. He lives near the area and has been a frequent visitor. This led to a natural interest and earlier this year, when he learned that part of a recent county grant to the area was based on having public access and outreach, he proposed and received approval for a chapter project that would support those objectives.

The Jacob's Well Natural Area is located at 221 Woodacre Dr. in Wimberley. The Natural Area consists of 55 acres owned and managed by the Wimberley Valley Watershed Association. A map is available [here](#).

The WVWA is a non-profit organization dedicated to protecting the region's water quality and quantity by promoting sustainable watershed management through education, conservation, and land protection. Matt Heinemann is the Program Director of the Jacob's Well Natural Area and is a coordinator for this project for the WVWA. Barbara Atwell,

In October, to support the public education and outreach goals, the center and trails opened to the public on Saturdays, from 10 am to 12 noon. Initial outreach efforts include tours of the center and trails, guided by volunteer docents. The docents discuss the importance of habitat restoration and native species, the aquifer and water conservation, and what people can do to have a positive impact on the area.

HCMNs have met several times with the WWA coordinators to develop a docent training plan. The HCMNs participating so far are Jeff, Margaret Baker, Karen Langridge, Jackie Mattice, Becky Northcut, and Andy Quittner. Each HCMN has been assigned a project to research and develop such as plants & habitat, geology, aquifer, history & native inhabitants. HCMNs are needed to serve as docents and the formal tours start in December.

HCMNs can also participate in habitat restoration which involves removal of impervious ground cover (which is mostly complete) and identifying and marking native plant and wildlife for the benefit of the public. HCMNs are also needed to identify and manage the invasive species and to help develop a long-term habitat management plan.

Other activities at the center include science and research. There is on-going research and exploration of the well, monitoring of water quantity and quality, and studying the effects of land development on the well and aquifer. There is a USGS monitor station at Jacob's Well. You can see the real-time data [here](#).

For recreation goals, the center has public campsites, trails, and managed access to the well.

There are many volunteer opportunities open to HCMNs at this interesting and unique natural area. This is a great chance to have a direct impact on the area's water quality and help protect this invaluable natural resource. ## *Onion Creek WQPL, Project #426: Workday November 8<sup>th</sup>*

Our work day turned out to be a soggy one. We assembled at the gate on Highway 967, ca. 5 miles East of the Salt Lick Restaurant and 3 miles East of Buda, at 8:30 am. Those volunteers attending were Art & Mary Arizpe, Deb & Nick Bradshaw, Ruben Garza, Debi Bowers, and Tom Watson.

By the time we drove from the gate to the work site on the flood plains of the creek, it had began to drizzle lightly. The work site is an area where the

Hays County Master Naturalists have been working off and on over the last four years to restore the native ecosystem (riparian habitat) which existed prior to modification for cattle ranching.

The objectives are to remove the encroaching Ashe Junipers and to plant native trees and shrubs grown from seeds collected along the creek. To date, approximately 2 acres of junipers have been felled and native plants are vigorously returning to the cleared area. Native tree saplings were planted further downstream in 2008 but survival was poor due to the extreme drought of that year.

Once at our destination, the volunteers set about the task of cutting juniper saplings that had sprung up after the larger junipers had previously been felled. Most of the crew went about downing the small saplings while Tom and Ruben took down larger trees along the stream banks and stumps that had re-sprouted in the treatment area.

Although we were able to work for only about 2 hours, all of the saplings and re-sprouted trees were removed and the crew moved down stream to fell other saplings along the floodplain. The eventual goal is to remove all Ashe Junipers along the flood plain on the North side and replacement with native shrubs and trees to restore the habitat as it may have been over 100 years ago.

While we would have liked to work longer, the intensity of the rain that ensued was such that we were soaked to the bone; however, we removed a significant amount of invasive plants. I said that as soon as we need more rain, I will schedule another workday!

The Sustainable Sites Initiative is an interdisciplinary effort by the American Society of Landscape Architects, the Lady Bird Johnson Wildflower Center and the United States Botanic Garden to create voluntary national guidelines and performance benchmarks for sustainable land design, construction and maintenance practices.

The central message of the Sustainable Sites Initiative is that any landscape—whether the site of a large subdivision, a shopping mall, a park, an abandoned rail yard, or even one home—holds the potential both to improve and regenerate the natural benefits and services provided by ecosystems in their undeveloped state. While there are existing standards for sustainable structures there are no comprehensive guidelines for those who want to create and measure sustainable landscapes. The Sustainable Sites Initiative Guidelines and Performance Benchmarks 2009 is intended to be a tool for those who design, construct, operate and maintain landscapes, including but not limited to planners, landscape architects, engineers, developers, builders, facility managers, horticulturists, governments, land stewards and organizations offering building standards.
